3. This is effective until terminated by a retraction in writing from the person granting the authorization.
4. The parent/legal guardian of the Frontier Girls member do release to Curiosity Untamed LLC any right, title and/or interest of any kind they may have in the records produced. I hereby grant to Curiosity Untamed LLC the right and authority to photograph, film and/or record vocally.
